INTELLECTUAL PROPERTY IN COURTS

Exploring relevant cases is crucial as they quide us in understanding how intellectual property rights evolve and play a crucial role promoting innovation and in creativity. In this the door of the High Court of United of Tanzania was knocked by various entities for determination of their intellectual property issues to which they seek Court guidance and determination. The cases summarized herein below depicts trademark concern like importance of registering one's trademark, acceptability of a trademark registration that will not likely confuse the public or create deception to ordinary consumers, and how passing off amounts to an infringement.

In the case of Godrej Consumer Products Ltd VS Target International (T) Ltd (Commercial Case No. 60 of 2019)[2023] TZHCComD 365 the High Court of United Republic of Tanzania in determining the issue of protectability of unregistered mark or mark which has been removed in the register of Trade or Service marks. The Court emphasized that trademark protection and rights are obtainable only through registration, and only the valid registered owner can take legal action against trademark infringement. the case of Clover SA In (Proprietary) Limited VS **Tropicana Products, INC (Civil** Appeal No. 102 of 2022) the High Court of United Republic of Tanzania was approached to determine similarity and confusion of the two mark " TROPIKA and TROPICANA" to which the Deputy Registrar decided that they are not similar and no likelihood of confusion. The Court in determining the aforementioned issue upheld the Deputy Registrar's decision, stating that the appearance evaluation showed distinctions "TROPIKA" mark between the "TROPICANA" mark. and The word TROPIKA was presented graphically with the word "Clover" at the top for the plaintiff, while the respondent's mark contains the logo "TROPICANA" preceded by a small leaf and the word "Essentials." The fonts and designs used were deemed different, making them neither identical nor confusing to an ordinary observer and thus upholding registration of the trademark TROPICANA. In the case of Multichoice (T) Limited VS Alphonce Felix Simbu & 2 Others (Commercial Appeal No. 01 of 2023)[2023] TZHCComD 363 the High Court held that the use of Alphonce Felix Simbu, Failuni Abdi Matanga and Gabriel Gerald Geay's images in Multichoice's advertisements amounted to breach of the right to privacy by passing off the image rights without their consent. This is because Multichoice had testified that they had no authorization to use the photos in their adverts. Corporate Updates

I. Tax Ombudsman Office of Tanzania

The Tax Ombudsman Office is a government body established with the sole purpose of addressing tax payers complaints and ensuring fair tax administration by the Tanzania Revenue Authority (TRA) in administration of tax laws. This Office was established in 2022 but was officially launched in December 2023.

The Tax Ombudsman has the power to listen and determine on matters relating to; noncompliance of procedures or mal-administration by TRA in administering tax laws, delay in release of documents or assets seized during the investigations of tax affairs, delay in responding to a complaint submitted by a taxpayer, or non response of letters or documents sent to TRA. However, do note that the Tax Ombudsman is limited to not determine on the following matters; review of legislation or tax policy, give a tax decision or object to a tax decision, and intervene in the policies or practices of the tax authority, except in cases related to service.

II. The Data Protection Act, 2022.

This law was passed by the President in 2022 but it officially came into operation on the 1st of May 2023. The objectives of this law is to regulate the collection and processing of personal data, ensure that the collection and processing of personal data of a data subject is guided by the principles of the law, protect the privacy of individuals, establish a legal and institutional mechanism to protect personal data, and provide data subjects with rights and remedies to protect their personal data from collection and processing that is not in accordance with the law. III. Mining (Corporate Social Responsibility) Regulations, 2023 (the Regulations) vide Government Notice No. 409 of 2023

The regulations mandate mineral right holders to annually formulate а credible corporate social responsibility plan, mutually agreed upon with the relevant local government authorities (LGAs) in the area where mining operations occur. The CSR plan should benefit the community; 40% to be set aside for projects within the community and 60% to be set aside for projects for the district, municipal or city council where the mining operations take place.

Mining rights holders are obligated to submit financial quarterly reports and annual reports to the Commission within fourteen days for the quarterly report and within sixty days for the annual report, detailing the funds used and projects implemented.

IV. Business Licensing Regulations (GN No. 626 of 2023)

These Regulations require business license applications to be made to the local authorities where the business is located and an application is to be made in a prescribed form. Upon application, the license application may be accepted, a fee payment be made and the license be issued; or an application may be rejected and reasons for rejection are to be communicated to the applicant within 14 days from the date the application was made.

Where one loses, destroys, tears or even where a license is not readable the issuing authority may issue another license after payment of a fee. Where one requires information from the license register about a license, they may request for such information by filling out a prescribed form.

V. Business Names (Beneficial Ownership) Regulations, 2023, GN No. 714 of 2023

The primary emphasis of these regulations is on partnerships

rather than companies. Managing partners in a partnership are required to prepare and maintain records of Beneficial Owners, which must be submitted to the Registrar of Companies. In cases where a partner lacks a beneficial interest in the partnership, they are obligated to submit a declaration to the partnership, disclosing the Beneficial Owners. Additionally, individuals not registered as partners but serving as beneficial owners are required to file a declaration confirming this status.

Note that disclosure of these records are to be done within 30 days from the date of registration of the partnership. Failure to comply with the requirements of this Regulation attracts a fine of not less than TZS 1,000,000/= but not more than TZS 5,000,000/=.

Capital Markets and Securities (Investment - Based Crowdfunding) Guidelines Government Notice No. 732 of 2023

This law establishes the legal requirements for crowdfunding activities in Tanzania. It ensures legal compliance and protects the interests of an investor when participating in crowdfunding activities; this is so as the Guidelines provide a structured and regulated environment that reduces risks, enhances transparency as well as ensures legal compliance.
